

# HQTS Guide for Exporting food to China under new 2022 Customs Regulations





# Provisions on the Administration of Registration of Foreign Enterprises Producing Imported Food

- The GACC (General Administration of Customs of China) updated its regulations on food imports.
- For governing food safety in the product origin, optimizing the registration procedures and clarifying the responsibilities of all parties
- It will be enforced since January 1, 2022.





# **1**<sup>st</sup> Change - Expand the scope of registration

## **Current Regulation**

- Production companies;
- Meat products (including casings), aquatic products, dairy products, bird's nest products, and bee products.

#### **New Regulation**

- Production companies, processing companies, and storage companies;
- All kinds of food exporting to China.













## 2<sup>nd</sup> Change – Adjustments on the registration method

## **Current Regulation**


 Recommended by the competent authority of the country (region) where the production company is located or other prescribed methods.

#### **New Regulation**

- Determine the registration method based on food category.
- Registration methods:
- ✓ recommended by the competent authority of the country (region) where they are located;
- ✓ applied by enterprises themselves or their agents.



## 2<sup>nd</sup> Change – Adjustments on the registration method



\* **High Risk Foods** include: meat and meat products, sausage casings, aquatic products, dairy products, edible bird's nests and the product thereof, bee products, eggs and egg products, edible fats and oils, stuffed flour products, edible grains, grain flour manufactures and malt, fresh and dehydrated vegetables and dried beans, seasonings, nuts and seeds, dried fruits, unroasted coffee beans and cocoa beans, prepackaged food for special dietary uses, and dietary supplements.



## 3<sup>rd</sup> Change - Scientifically adjust registration application materials

#### Registration recommended by the competent authority

(1) Recommendation letter from the competent authority of the country (region) where it is located;

(2) List of enterprises and application form for registration;

(3) Enterprise identification documents, such as business license issued by the competent authority of the country (region) where it is located;

(4) A statement that the competent authority of the country (region) recommends that the enterprise meets the requirements of these regulations;

(5) The audit report of the relevant enterprise from the competent authority of the country (region).

When necessary, the GACC may request documents of the enterprise's food safety, hygiene and protection system, such as the floor plan of the factory area, workshop, and cold storage, as well as process flow diagrams, etc.

#### **Registration applied by enterprises**

(1) Application form for business registration;

(2) Enterprise identification documents, such as business license issued by the competent authority of the country (region) where it is located;

(3) A statement that the enterprise promises to meet the requirements of this regulation.



## 4<sup>th</sup> Change - Innovate registration approval methods

## **Current Regulation**

- The GACC organizes relevant experts or designated agencies to review the materials submitted by the competent authority or using other prescribed methods to review the materials;
- Form an assessment team (more than 2 members) for on-site assessment according to work needs.

#### **New Regulation**

- The GACC organizes an assessment team (more than 2 members) by itself or by entrusting relevant agencies to conduct an assessment;
- · Examination forms:
- ✓ Examination of materials, or
- ✓ Video inspection, or
- ✓ On-site inspection, or
- $\checkmark\,$  Combination of above.



## 5<sup>th</sup> Change - Clarify registration number management



#### **Current Regulation**

Mark the registration number on the **outer packaging** of their food exported to China.

## **New Regulation**

Mark the food's internal and external packaging with

- ✓ the registration number in China; or
- ✓ the registration number approved by the competent authority of the country (region) where it is located.



## **6<sup>th</sup> Change - Clarify label requirements for dietary supplements**

## **Current Regulation**

Must be with Chinese

Can be pasted or printed on the final sales packaging

## **New Regulation**

Must be with Chinese

Must be printed on the final sales packaging





## 7<sup>th</sup> Change - Extending the validity period of registration

The new regulation extends the validity period of the registration from 4 years to 5 years, so the production license of foreign enterprises exporting food to China is synchronized with the Chinese domestic food production license in terms of validity.

Current Regulation

## 8<sup>th</sup> Change - Clarify the application materials required for the renewal

#### **Current Regulation**

No application materials for the renewal are listed.

**New Regulation** 

Proof materials related to the renewal. If the GACC considers that it can be renewed after evaluation, it shall be renewed.

If the renewal is related to the change of production site, the legal representative, or the registration number granted by the country (region), the registration should be re-applied, and the previous registration number in China will automatically become invalid.



## 9<sup>th</sup> Change - Application materials required for validity extension

#### **Current Regulation**

No application materials for the validity extension are listed.

#### **New Regulation**

- Application form for extension of registration;
- A statement that promises to continue to meet the registration requirements. The GACC will extend the registration of enterprises that meet the registration requirements, and the registration validity period will be extended by 5 years.

If a foreign enterprise producing imported food needs to extend its registration, it shall submit an application for extension of registration to the GACC through the registration application channel within *3 to 6 months* before the expiration of the registration validity period.



## 10<sup>th</sup> Change - Clarify the responsibilities of all parties

## **Current Regulation**

Only when the competent authority finds that the foreign food production enterprise that has been registered cannot continue to meet the registration requirements during the review, the enterprise shall be supervised to complete the rectification within the prescribed time limit.

#### **New Regulation**

- The competent authority of the country (region) where the foreign production enterprise is located shall supervise the registered enterprise to continue to meet the registration requirements.
- When registered enterprises find that they do not meet the registration requirements, they should take the initiative to suspend exports to China and take immediate corrective actions.

Clarify the responsibilities of all parties, strengthen the main responsibilities of foreign production enterprises and the supervisory responsibilities of the competent authority of the country (region), and improve the supervision during and after the registration.



## 11<sup>th</sup> Change - Reducing the scope of competent Authorities

#### **Current Regulation**

The competent authorities of the countries (regions) where the foreign food production enterprises are located in current regulations include **the official departments, officially authorized institutions, and industry organizations** in the countries (regions) where the foreign food production enterprises are located.

#### **New Regulation**

The competent authority of the country (region) in new regulations refers to **the official department** responsible for the safety and health supervision of the food production enterprise in the country (region) where it is located






## **Application Materials**
